<p>I would like to be a Bus Counselor. Bus counselors are hired to ensure that each camper has a safe ride to and from camp. Bus counselors help each camper get on the bus in the morning and off the bus in the afternoon. Bus counselors act as our 'eyes and ears' and work as a team with the bus driver. Bus Counselors get paid \$300 plus tips. If you are chosen as a Bus Counselor, you will be notified in the beginning of June.</p>				
<p>I would like to ride on a Rolling Hills Bus (but NOT be a Bus Counselor). Many of our staff choose to ride on a Rolling Hills bus to and from camp. As space allows, Rolling Hills will ATTEMPT to provide transportation for staff members who choose this option. You will have to meet the bus at a designated stop close to your home, but you will NOT be picked up and dropped off at your door.</p>				
<p>I have my own car and would like to drive to and park at camp. You MUST apply for a parking permit and MUST have 2 other staff members plus the driver (total of 3) in the car in order to be considered for this request.</p>				
<p>I have my own car and would like to use the Rolling Hills Shuttle Bus, which departs from the Maple Tree shopping center (Old Mill Road and Route 79) in the morning and returns there after camp. This is a GREAT OPTION for staff members, especially for those staff members who have a provisional license and are not allowed to drive more than 1 non-family member.</p>
